WHEREAS, a plat of survey related to the Condominium prepared by Eston Pendley and Associates, Inc. dated February 10, 1999 and last amended on March 16, 1999, was filed on June 21, 1999 in Condominium Plat Book 11, Pages 86-88, as revised by that certain plat of survey dated February 10, 1999 and last amended on March 16, 1999, filed on October 8, 1999 in Condominium Plat Book 11, Page 131, Fulton County, Georgia Records (hereinafter referred to as the "Condominium Plat");

WHEREAS, a revised Condominium Plat is being simultaneously recorded herewith in Condominium Plat Book 247, Pages W-W2, et seq., Fulton County, Georgia Records to show the additional parking spaces being assigned to units as limited common elements as set forth in this Third Amendment;

WHEREAS, floor plans relating to the Condominium prepared by Ray Engineering, Inc. were filed on June 21, 1999 in Condominium File Cabinet No. 2, Folder No. 381, Fulton County, Georgia Records;

WHEREAS, Paragraph 6(b) of the Declaration provides that the Association's Board of Directors, without need for a membership vote, is hereby authorized to assign a common element not

previously assigned as a limited common element to a unit, provided that any such assignment shall be made in accordance with Section 44-3-82 of the Georgia Condominium Act, O.C.G.A. § 44-3-70, <u>et seq.</u> (1991 and Supp. 2002) (hereinafter referred to as the "Act");

WHEREAS, pursuant to Section 44-3-82 of the Act, all affected Unit Owners must consent to and execute an amendment that assigns a common element not previously assigned as a limited common element;

WHEREAS, certain Unit Owners in the Condominium desire that the Board of Directors of the Association assign certain portions of the common elements as limited common element parking spaces as -more particularly set forth in Exhibit "D" attached hereto and incorporated herein and into the Declaration by this reference;

WHEREAS, the Association's Board of Directors and all affected Unit Owners desire to consent to the assignment of limited common element parking spaces in accordance with Exhibit "D" attached hereto and incorporated herein and into the Declaration by this reference;

WHEREAS, this Third Amendment does not alter, modify, change or rescind any right, title, interest or privilege held by any mortgage holder of any Unit; provided, however, in the event a court of competent jurisdiction determines that this Third Amendment does alter, modify, change or rescind any right, title, interest or privilege held by any such mortgage holder without such mortgage holder's consent in writing to this Third Amendment, then this Third Amendment shall not be binding on the mortgage holder so involved, unless such mortgage holder consents to this Third Amendment, and if such consent is not forthcoming, then the provisions of the original Declaration prior to this Third Amendment shall control with respect to the affected mortgage holder; and

NOW, THEREFORE, in accordance with O.C.G.A. §44-3-82 of the Georgia Condominium Act and Paragraph 6(b) of the Declaration, the Declaration is amended as follows:

WHEREAS, the Condominium plat for Melrose Park Condominium, dated February 10, 1999 and last amended on March 16, 1999, was recorded in Condominium Plat Book 11, Pages 86-88 and 131, Fulton County, Georgia Records; and

WHEREAS, floor plans for Melrose Park Condominium are filed in Condominium File Cabinet No. 2, Folder No. 381, of the Fulton County, Georgia Records; and

WHEREAS, Melrose Park Condominium Association, Inc., a Georgia nonprofit corporation, is the "Association" as said term is used and defined in the Declaration; and

- 1. Section 19(e) of the Declaration entitled "Right of Action" is hereby deleted in its entirety and the following substituted therefor:
  - (e) This Section is intentionally left blank.
- 2. Except as otherwise defined herein, capitalized terms, as used in the Amendment, shall have the meanings ascribed to such terms in the Declaration.
- 3. Except as amended hereby, the Declaration shall remain in full force and effect.
